## **BACKGROUND**

The Alcohol, Drug Addiction and Mental Health Services Board for Montgomery County has experienced extensive delays in submission of claims to the MACSIS System by contract providers. This condition impacts:

- 1. The board's timely submission of year-end reports to Ohio Department of Mental Health (ODMH) and Ohio Department Alcohol Drug Addiction Services (ODADAS)
- 2. Board funding being held by the State
- 3. Independent auditors timely completion of the annual audit of our providers
- 4. Board's completion of year-end financial reconciliation's
- 5. Funds being returned to the State.

## **POLICY**

The Board shall annually reconcile payments made to providers by the Board for non-Medicaid services providers rendered against the non-Medicaid revenue earned through MACSIS, less that portion of the payments made for certain services (vocational rehabilitation, forensic, etc.) paid on a block grant basis.

If the board payments for non-Medicaid services exceed providers' earnings for non-Medicaid services, the provider shall reimburse the Board for the unearned revenue.

# **PROCEDURE**

#### **Cut off Date**

In order to meet ODMH and ODADAS reporting requirements, timely completion of financial audits, timely completion of financial planning by the ADAMHS Board and to maximize utilization of funds for the provision of services to clients, the ADAMHS Board will require the following:

Providers' must submit all non-Medicaid claims (non-Medicaid eligible services and Medicaid eligible services rendered to non-Medicaid clients both Alcohol & Other Drug and Mental Health) for services provided in the previous fiscal year to the Board by September 15<sup>th</sup>. This in effect should include all non-Medicaid services provided during the fiscal year ended June 30<sup>th</sup>.

- Medicaid claims must be submitted so they are processed within 365 days of date of service.
- This includes claims and also all claims appeals.
- After the first production run following September 15<sup>h</sup> each year, board staff will change the system build in Diamond so that all Non-Medicaid services for previous fiscal year will pay at \$0.00 (zero dollars)

# Waiver Request

If an agency requests a waiver of the deadline, it must be done in writing to the ADAMHS Board for Montgomery County prior to September 15..
